The Action's website is in operation since October 2010 and has been updated on a weekly basis since then by Antonio Mendes or Juliette Hueber (FR). It features in March 2014 73 screens, under 4 main headings, and gives access to 72 texts under pdf format. Statistics show a large and ever increasing audience, from 7000 unique visitors and 45000 page views in 2011 to 34 000 unique visitors and 630 000 page views in 2013, meaning that the audience has quintupled and that more time is spent on the website.
